

General Information

1. Entry fees include court time, balls, lunch, refreshments*, and awards to First, Second, Third and Consolation winners. Divisions with less than 6 entrants will have First and Second awards only.
*Refreshments generously donated by Coca-Cola of Alaska.
2. Players may play in 1 skill level and 2 events total.
3. Players must check in 30 minutes prior to a match. Courts will be assigned when all players have checked in for the match. 15 minutes late for a match may result in a forfeit.
4. Match winners must referee or find a suitable replacement. Last round match winners are required to show up and referee first round matches the next day. Failure to do so will result in a forfeit.
5. Official Ball: Wilson
6. The tournament director reserves the right to:
 - a. Reclassify players
 - b. Combine or cancel divisions with less than 6 entrants.
 - c. Advance, delay or reschedule matches as needed.
7. USRA approved lensed eyewear is required apparel for all players. The protective eyewear must be worn as designed and may not be altered. Players who require corrective eyewear must also wear lensed eyewear designed for racquet sports. Failure to wear protective eyewear will result in a technical, and the player will be charged with a time-out to secure eyewear. The second infraction in the same match will result in a forfeit. (USRA rule 2.5)
8. Children must be supervised at all times during the tournament.

ENTRY FEES

\$50 members and \$60 nonmembers per participant for the first event; \$15 for second event; \$25 for Juniors (18 yrs & under) for first event. Juniors must play in a Junior division as their first event. All faxed entries must have credit card information or member number to be accepted. Fax entry to: (907) 561-2946. Players may enter in 1 skill level only and 2 events total.

**All tournament participants will be required to pay a \$15 AARA membership fee. If you are a current United States Association of Racquetball (USAR) member then you will not need to pay another membership fee. We will have a current roster for both AARA and USAR members at the tournament desk.

ENTRY DEADLINE

Applications must be turned in to The Alaska Club Midtown or East by 5pm on Sunday, March 29. No refunds will be given after the draw is posted.

STARTING TIMES

Draw will be posted by 4pm on Wednesday, April 1, at The Alaska Club Midtown. A copy of the draw will also be posted online at: www.alaskaracquetball.com. All local players must check the draw at the club or online for starting times. Out of town players may call the front desk after 4pm on Wednesday for their starting times. PLEASE DO NOT CALL THE TOURNAMENT DIRECTOR FOR STARTING TIMES.

Penalties for Unsportsmanlike Conduct:

Familiarize yourself with USRA rule 3.17 Technical Fouls & Warnings. Any player displaying behavior described in this rule (or behavior considered unsportsmanlike by the tournament staff or match referee) will be issued a technical (loss of a point). A second infraction results in forfeiture of the match and from the tournament. Any player forfeited for unsportsmanlike behavior must be referred to the AARA board by the tournament director within seven days. The board will send the player a letter warning them that a second forfeiture in any 18-month period results in an automatic six-month suspension of AARA membership. Remember, if you are forfeited from a match, you are automatically forfeited from the tournament.

MATCHES

All matches will be 2 games to 15 with tie-breakers to 11. Consolation matches are 2 out of 3 games to 11, except the finals which are regular matches.
