

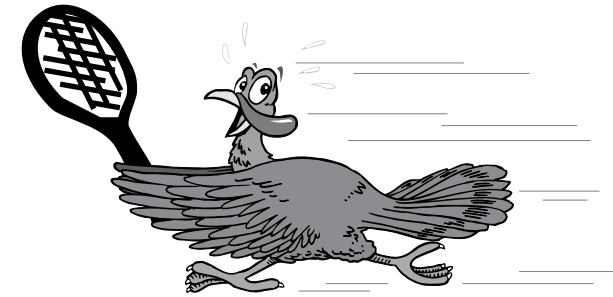
# General Information

1. Entry fees include court time, balls, lunch, tournament t-shirts, refreshments,\* and prizes awarded to first place winners. Divisions with less than six entrants will have first and second awards only. Refreshments and a Turkey Luncheon will be provided on Saturday the 19th courtesy of the AARA and The Alaska Club.
2. Players may play in one skill level and two events total.
3. Players must check in 30-minutes prior to a match. Courts will be assigned when all players have checked in for the match. 15-minutes late for a match may result in a forfeit.
4. Match winners must referee or find a suitable replacement. Last round match winners are required to show up and referee first round matches the next day. Failure to do so will result in a forfeit.
5. Official Ball: Wilson
6. The tournament director reserves the right to:
  - a. reclassify players
  - b. combine or cancel divisions with less than six entrants.
  - c. advance, delay or reschedule matches as needed.
7. USRA approved lensed eyewear is required apparel for all players. The protective eyewear must be worn as designed and may not be altered. Players who require corrective eyewear must also wear lensed eyewear designed for racquet sports. Failure to wear protective eyewear will result in a technical, and the player will be charged with a time-out to secure eyewear. The second infraction in the same match will result in a forfeit. (USRA rule 2.5)
8. Children must be supervised at all times during the tournament.
